

## ABSTRACT OF VACANCY CALL: AS 09-2019 ISMAR NA

### DESCRIPTION OF PROGRAM/PROJECT:

The successful candidate will contribute to the ISMAR-CNR research activities in the framework of the Copernicus Marine Monitoring Service - Multi-Observation Thematic Assembly Centre (CMEMS-TAC-MOB). The research will focus on one or more of the following topics: 1) the development of innovative products for the marine environment monitoring, that could in the future be proposed as operational products within Copernicus Programme; 2) the analysis of observation/model time series to study 3D ocean circulation and its impact on marine environment and global climate; 3) the test/implementation of "machine learning" techniques for the analysis/retrieval of the ocean state from combined marine observations (satellite/in situ). The successful candidate will be introduced in a stimulating international and interdisciplinary framework and they will be asked to lead/contribute to the dissemination of their results through scientific publications, project reports, and presentations at national/international meetings.
