The National Institute of Optics is accepting applications for n. 1 post graduate researcher position in the field of "Physics" on the following topic: "Intense Lasers and Laser-Plasma Interaction";

The position will be granted for 12 months.

The annual gross salary is € 19.367, paid in twelve monthly installments.

The selection procedure is carried on the basis of relevant qualifications including, degrees and awards obtained, postgraduate activity, scientific activity and publications etc.. (up to 70/100 points, score not lower than 42/70) and on the basis of an interview (up to 30/100 points, minimum score 18/30).

The research grant cannot be cumulated with scholarships provided by the CNR or other organizations and research institutions, except those granted by the CNR or national or foreign institutions which aim to support the research activities of grant holders with visiting periods abroad. Successful applicants may attend PhD courses, without scholarship.

- a) Degree in Physics;
- c) Fluency in written and oral English;
- d) Basic knowledge of Italian language (for foreign applicants only);
