Copernicus Marine Environment Monitoring Service (CMEMS) OCEAN COLOR-TAC

RESEARCH AREA: Oceanography/Satellite Oceanography

RESEARCH THEME: The research activities for this position will be part of the COPERNICUS project's CMEMS Ocean Color Thematic Assembly Centre (TAC). The winner candidate will be employed in satellite ocean color data production, validation and distribution to users, as well as the development of new ocean color algorithms for e.g. new spaceborne sensors.

CONTRACT DURATION: one year, renewable

SALARY: 26.000,00 Euro per year, pre tax pay.

QUALIFICATIONS AND EXPERIENCE: optical oceanography, satellite oceanography, ocean color remote sensing
